Panelists

Peter Bridgewater has served as Secretary General of the Ramsar Convention on Wetlands of International Importance since 2003. He previously worked with UNESCO as Director of the Division of Ecological Sciences and as Secretary of the Man and the Biosphere Programme. His earlier career included appointments as Chief Scientist of the UK Nature Conservancy Council and Chief Executive of the Australian Nature Conservation Agency. Mr. Bridgewater has written or edited more than 170 publications on nature conservation, vegetation science and biodiversity issues.

Kemi Awoyinka is the Wetlands and Poverty Alleviation Officer of Wetlands International. She also acts as Coordinator of the Wetlands and Livelihoods Working Group of Wetlands International. This Working Group includes representatives from development assistance and environmental organisations around the world. By creating such partnerships between the poverty reduction and conservation communities, the Working Group aims to strengthen the cross fertilization of ideas and perspectives on wetland, water and poverty issues and highlight priorities for strategic interventions.

Sibylle Vermont is a biologist (botany and zoology) with an MSc on savanna ecology and a specialization in environmental policy. Since 1991, with the Swiss Agency for the Environment, Forests and Landscape/Ministry for the Environment. Dealt with European integration and projects in Eastern and Central Europe (biodiversity and water), environment and health, environment under the Economic Commission for Europe of the United Nations (UNECE). Since 1999, focusing on water, on issues like civil liability for accidental water pollution and now mainly on integrated water resources management. Chair of the IWRM group of the UNECE Convention of the Protection and Use of Transboundary Watercourses and International Lakes (Water Convention).
