## UNEA contributions to 2030 Agenda

- ❖ Through the different resolutions provided UNEP and the environmental community around the world a direction on how to achieve the implementation of the environmental dimension of the 2030 Agenda;
- ❖ Identified concrete partnerships, policies and tools that can facilitate achievement of the 2030 Agenda and SDGs;
- ❖ Showcased practical experiences on how to integrate the environmental dimension of sustainable development into national planning processes, and build capacity to track progress.



## Resolution 2/5: “Delivering on the 2030 Agenda for Sustainable Development”

**UNEA:** contributing to the effective implementation of the env dimension of 2030 Agenda in an integrated manner (setting the global env agenda, providing policy guidance and defining policy responses, undertaking policy review, dialogue and exchange of experiences, fostering partnerships for achieving env goals and resource mobilization);

**UNEP:** to enhance activities, in cooperation with other UN entities, in **support** of the **coherent, coordinated and integrated implementation** of the env dimension of 2030 Agenda **at national, regional and global levels, and in the UN system**


- (a) Fostering **partnerships** and other means of **cooperation** with other relevant United Nations bodies;
- (b) Engaging with **regional coordination mechanisms**, as appropriate;
- (c) Actively promoting the **integration** of the environmental dimension **into United Nations development assistance frameworks** at the country level;
- (d) Enhancing **institutional and human capacity building** at the national, regional and international levels;

# Resolutions

- 2/18: Relationship between UNEP and the multilateral environmental agreements for which it provides the secretariat;
- 2/19: Midterm review of the Programme for the Development and Periodic Review of Environment Law (Montevideo Programme IV);
- 2/20: Proposed medium-term strategy for 2018-2021 and programme of work and budget for 2018-2019;
- 2/21: Sand and dust storms;
- 2/22: Review of the cycle of sessions of UNEA of UNEP
- 2/23: Management of trust funds and earmarked contributions
- 2/24: Combating desertification, land degradation and drought and promoting sustainable pastoralism and rangelands
- 2/25: Application of Principle 10 of the Rio Declaration on Environment and Development in the Latin America and Caribbean Region

## Highlights of selected resolutions

### 2/22: Review of the cycle of sessions of UNEA of UNEP

- Change of UNEA cycle from even to **odd years**
- **UNEA-3** to be held 4-6 December 2017 (back-to-back with OECPR, 3 days)

### 2/1: Amendments to the rules of procedure

- Election of UNEA Bureau members **of UNEA at the end** of a cycle

### 2/19: Medium Term Strategy 2018-21 and POW and budget for 2018-2019

- Approves MTS 2018-21
- Approves Environment Fund budget 2018-19: USD 271 million
- Results-based management POW and budget
- Encourages increase in voluntary contributions to the Environment Fund, including broadening of donor base



# Selected Resolutions

## 2/5: Delivering on the 2030 Agenda for Sustainable Development

- Commits UNEA and UNEP to SDG implementation, including HLPF input from UNEAs
- Promotes enhanced coordinated, coherent and integrated delivery on the environmental dimensions of SDGs
- Initiate new multi-stakeholder partnerships with private sector and CSOs
- Enhances science-policy interface on environmental dimension on SDGs

## 2/6: Supporting the Paris Agreement

- Requests UNEP to contribute to the pre-2020 efforts on climate change, including through education, training public awareness, public participation etc.
- Strengthen support to IPCC
- Strengthen support to global climate change related assessments



# Selected Resolutions

## 2/7: Sound management of chemicals and waste

### Preamble

- Sound management of chemicals and waste essential to sustainable development
- Welcomes coordination and cooperation in the chemicals and waste cluster
- Waste management is a serious challenge and a priority
- Concern about health and environment impact from lead-acid batteries

### Meeting the 2020 goal and beyond

- Sound management of chemicals and waste should be a priority in national strategies
- UNEP to coordinate sound management of chemicals and waste for the achievement of the SDGs
- Issue by 2017 an Overview on policies and actions to reach the SDGs
- UNEP to continue work on lead and cadmium



# Selected Resolutions

## Waste

- Integrate environmentally sound management of waste into UNEP's strategies and policies
- Strengthen the IETC as a global center of excellence on waste management
- Issue by 2019 an update of the Global Waste Management Outlook
- Countries to enhance work on lead-acid batteries
- UNEP to assist countries on environmentally sound management of waste

## Chemicals

- Stakeholders to submit information on sustainable chemistry by June 2017
- UNEP will prepare a report in Q1 2018 based on these submissions
- UNEP will work with WHO on environmentally persistent pharmaceutical pollutants
- Issue by end 2018 an update of the Global Chemicals Outlook



# Selected Resolutions

## 2/8: Sustainable consumption and production

- Encourages achievement of SDG 12, improvement of global resource efficiency and decoupling of economic growth from environmental degradation
- Encourages the move towards SCP patterns, promotion of life-cycle approaches, integration of sustainability into each stage in product life cycles, and facilitation of markets for secondary materials
- Encourages the initiation of partnerships and alliances on resource efficiency
- UNEP to facilitate cooperation and information sharing on SCP
