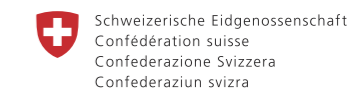

Ecosystem restoration entails assisting in the recovery of ecosystems that have been degraded or destroyed, as well as conserving the ecosystems that are still intact.

The **UN Decade on Ecosystem Restoration (2021 -2030)** is a clear opportunity to strengthen action for nature and people, by employing **Nature-based Solutions (NbS)** to safeguard food security and clean water, and halt biodiversity loss and climate change.
