16. CITES Strategic Vision

CITES Strategic Vision: 2021 – 2030

The Kunming-Montreal Global Biodiversity Framework (GBF) was adopted in December 2022. CITES processes contribute to the implementation of the GBF and relevant processes and documents to reflect this contribution.

- *Secretariat reports on:*
 - linkages between the strategic vision, the SDGs and the Kunming-Montreal Global Biodiversity Framework; and proposes amendments to the Resolution on *Cooperation of CITES with other biodiversity-related conventions* to ensure the long-term contribution of CITES to the GBF
 - possible indicators for objective 1.4 of the CITES Strategic Vision: “The Appendices correctly reflect the conservation status and needs of species”
- *Standing Committee invited to:*
 - *Review the areas of alignment and submit the proposed amendments to the Resolution to the Conference of the Parties at its next meeting;*
 - *Consider the proposed indicators for objective 1.4 in the strategic vision*



18. Cooperation

Cooperation with other biodiversity related Conventions and other international organizations

- *The Secretariat presents:*
 - *Next steps in developing a partnership strategy*
 - *Opportunities for highlighting the achievements of CITES and advancing on synergies: UN Environment Assembly (UNEA6), February 2024; Bern III Conference on synergies, week of 20-26 January 2024 (to be confirmed)*
- *Standing Committee invited to*
 - *consider the process outlined for the development of the draft CITES partnership strategy and provide any inputs;*
 - *coordinate the participation of its Members at the Bern III Conference on synergies to ensure that the Convention and its interests are adequately represented at the conference; and*
 - *encourage Parties participating in the UNEA-6 high-level dialogues to represent the achievements, needs and interests of CITES and its Parties.*



12. Emerging operational matters

Following the COVID-19 pandemic, there is a need to consider the approach to organize meetings in similar circumstances in the future to ensure that work progresses

- *Secretariat proposes:*
 - *Two guiding principles for the best course of action if intersessional work/meetings are affected by exceptional circumstances: (1) **in-person meetings are the default options** for all meetings of the CITES permanent committees; and (2) **online or hybrid options would be considered only when quorum** might not be reached;*
 - *Further, a postponed meeting should take place within six months of the original date and decision to be made within two months – otherwise meeting to be rescheduled online;*
 - *Amendments to a Resolution to allow for statements to be made on behalf of a Party unable to attend a meeting*
- *Standing Committee inter alia invited to:*
 - *consider the guiding principles and the exceptional circumstances*
 - *submit to the Conference of the Parties the amendments to Resolution Conf. 18.2 on Establishment of Committees*

33. Compliance matters – Application of Article XIII

- *Resolution Conf. 14.3 (Rev. CoP19) – supportive and non-adversarial approach is taken towards non-compliance with the aim of ensuring long-term compliance*
- **Overview document – Viet Nam, UK and other matters**
- **Guinea, Lao PDR, Nigeria, Democratic Republic of Congo**
 - *Secretariat provides an update on the implementation of recommendations of the Standing Committee*
 - *Standing Committee invited to*
 - *note progress made by the respective Parties*
 - *adopt new recommendations or renew existing ones*
- **Bangladesh, Cameroon, China, Ecuador, European Union**
 - *Secretariat reports on compliance matters identified by its technical compliance missions to the Parties:*

National laws and annual reporting

31. National laws for implementation of the Convention

 - progress (or lack thereof) of Parties with legislation in Category 2 or 3 (25 updates received)
- *Standing Committee invited to:*
 - agree on a recommendation to all Parties to suspend commercial trade with: Comoros, Congo, Dominica, Ecuador, Libya, Mongolia and Sierra Leone
 - request the Secretariat to issue a formal warning to the Parties that have not reported any legislative progress for more than three years : Azerbaijan, Belarus, Bosnia and Herzegovina, Kenya, Kyrgyzstan, Lebanon and North Macedonia
 - agree to add Uganda to the list of Parties that requires the attention of the Committee as a priority.

32.1 National reports: Submission of annual reports

33. Compliance matters - – Application of Art. XIII (2)

Expedited application of Article XIII for West African rosewood (Pterocarpus erinaceus) for all range States and the review of significant trade in Pterocarpus erinaceus

- *Secretariat provides an update on the implementation of recommendations of the Standing Committee:*
 - *Cameroon, Central African Republic, Chad, **Gambia (the)***, Guinea, **Guinea-Bissau***, **Mali***, **Nigeria*** and **Togo**: currently subject to a recommendation to suspend trade in *p. erinaceus* until fulfilment of certain conditions*
 - *Benin, Burkina Faso, Ghana, Sierra Leone: must prepare non-detriment findings in order to be able to export*
 - *Côte d’Ivoire, Niger and Senegal: have adopted zero-export quotas*
- *Sierra Leone provides information on progress made to develop an NDF for *P. erinaceus**
- *Senegal highlights capacity constraints for Parties in West Africa – and proposes a range-State approach in providing support*
- *Standing Committee invited to*
 - *note progress made by the respective Parties*
 - *Consider information provided by Sierra Leone*
- ***Malagasy ebonies (*Diospyros spp.*) and palisanders and rosewoods (*Dalbergia spp.*)***
 - *Madagascar presents an update on the implementation of Decision 19.71 and recommendations of SC75*
 - *Standing Committee invited to note the progress reported by Madagascar*

39.1 Enforcement matters

- *Secretariat reports on*

Illegal fishing of totoaba and the threat this poses to the Vaquita remains a matter of great concern. Countries of origin, transit and destination need to take action to combat illegal trade in totoaba

39.3 CITES Big Cat Task Force

- *Secretariat reports on the outcome of the meeting of the Big Cat Task Force, held in Entebbe, Uganda, in April 2023, including the outcome document recommending measures in the following areas:*

41.2 Asian big cats in captivity

Secretariat was requested to undertake missions to identified Parties in whose territories there are facilities which may be of concern keeping Asian big cats in captivity, with the purpose of gaining a better understanding of the operations and activities undertaken by these facilities.

 - *Reports on findings and conclusions from missions undertaken to : Czech Republic, Lao PDR, South Africa, Thailand and Viet Nam*
- *The Standing Committee is invited to consider:*
 - *A number of recommendations directed to Parties in whose territories there are facilities keeping Asian big cats in captivity, which inter alia relates to:*
 - *strengthening compliance monitoring and enforcement of legislative provisions relating to facilities keeping tigers in captivity*
 - *taking a more methodical proposed approach regarding facilities that breed large numbers of tigers and facilities housing large numbers of tigers*
 - *to enhance their efforts in demand reduction activities related to illegal trade in Asian big cats*
 - *Specific recommendations directed to the Parties visited during the missions.*
 - *Encouraging governments, intergovernmental organizations, international aid agencies, and nongovernmental organizations to provide funds and other assistance to Parties with facilities that breed large numbers of tigers and those housing large numbers of tigers, to support the implementation of the methodical approach proposed.*



Species-specific enforcement matters

 - *consider recommendations specific to the Parties mentioned*
 - *request Parties included in the Directory of illegal trade in rhinoceros horn focal points, to inform the Secretariat if the details of their national focal points in the Directory should be updated*

39.2 International Consortium on Combatting Wildlife Crime (ICCWC)

- *Secretariat reports on*
 - *Activities conducted under the auspices of ICCWC*
 - *The ICCWC Vision 2030 which provides a roadmap for the activities of ICCWC over the next decade*
 - *ICCWC continue to play a critical role in engaging and working with Parties globally to combat wildlife crime, using a coordinated and cohesive approach and providing Parties with the tools, services and technical support needed to address wildlife crime and bring criminals involved to justice*
- *Standing Committee invited to*
 - *note the efforts of Parties to combat wildlife crime and welcome the support provided by ICCWC*

21. CITES and Forests

The strategic importance of CITES in the conservation of forests and sustainable forest management will be discussed, building on the collective knowledge, resources, mechanisms and networks of the existing global governance framework on forests

- *Secretariat reports on*
 - *progress in preparing a 'CITES and forests compendium: CoP19-CoP20';*
 - *preparations of a multidisciplinary study on CITES and forests;*
 - *the scope of new initiatives as agreed by the Plants Committee that will initially focus on CITES-listed tree species although eventually the scope could include all forest species of fauna and flora;*
 - *its efforts to enhance and raise awareness on CITES contributions to global forest-relevant mandates and forest policies and initiatives.*

 - *explore options aligned with the CITES Strategic Vision to:*

17. Role of CITES in reducing the risk of future zoonotic disease

- *Israel and Singapore are chairing the Standing Committee working group on the topic and report on discussions related to the establishment of a CITES advisory body to provide guidance to Parties.*

 - *responses received from Parties about any measures they have in place to prevent and mitigate the risk of pathogen spillover and transmission from wildlife trade and associated wildlife supply chains, including markets,*

35. Review of significant trade

Process designed to:

- *identify species that may be subject to unsustainable levels of international trade and*
- *identify remedial measures to ensure that the export of Appendix-II listed species takes place at a level that will not be detrimental to the survival of that species*

118 species/country combinations are currently subject to review:

- *79 – fauna (of which 19 will be reviewed in detail at SC77)*
- *39 – flora (of which 15 will be reviewed in detail at SC77)*

48 of these are currently subject to a Standing committee recommendation to suspend trade

At SC74, actions to implement remedial measures were proposed for a number of the other species/country combinations aimed at improving science-based conservation and management actions

Recommendation to SC: *Decide on necessary action and make recommendations to range States for the 34 cases due for reporting at SC77.*

36. Review of trade in animal specimens reported as produced in captivity

A large proportion of international trade involves individuals that are reported as bred in captivity. Convention provides for special treatment of animal species that are bred in captivity as defined by the Parties.

Concerns: incorrect application of source codes / misuse or false declarations of source codes / legal origin of parental stock
Process agreed by Parties: Review biological, trade and other relevant information regarding animal species subject to significant levels of trade (Source codes: C, D, F and R)

At SC74: 11 species/country combinations retained in review process (incl tortoises, monitors, seahorses, cockatoos and the fennec fox)

Recommendations — implementation assessed by Secretariat in consultation with Animals Committee

The Standing Committee is invited to

Decide on appropriate actions and make recommendations to the country or countries concerned, incl. remove species / country combinations from the review (8 combinations) / retain in review (3 combinations)
